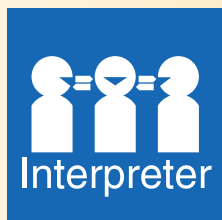


## Eastern Community Legal Centre

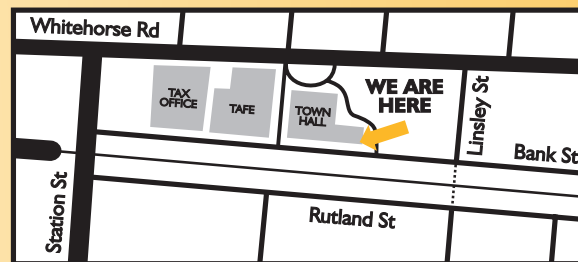

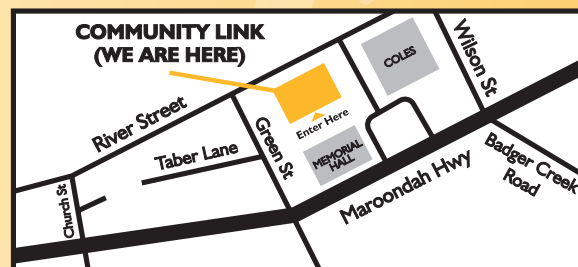

## Common Types of Legal Problems

- Family Law
- Family Violence and Intervention Orders
- Victims of Crime
- Fines and Infringements
- Minor Criminal matters
- Car Accidents
- Problems with your Neighbour
- Tenancy
- Debt
- Consumer Issues

There are some areas of law ECLC cannot help with but can often refer people to appropriate services.



## Ongoing Assistance

ECLC has guidelines as to when we can provide further help. Casework may be offered to people who are disadvantaged. This depends on many factors but generally we may be able to assist people who:

- Are Centrelink recipients or low income earners
- Have difficulty in understanding or coping with the legal process
- Have compelling circumstances such as mental health or difficult financial issues
- Have a legal matter that has a public interest component and likely to succeed
